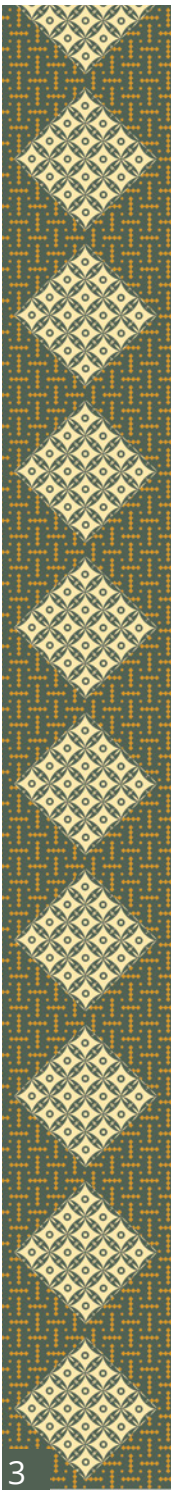

PLENARY: Defending our defenders

Never has it been more important to fight for land and environmental rights and never it has been more dangerous. People and communities are finding themselves on the frontline of defending their land and territories from corporate or state abuse and exploitation, facing threats, criminalisation, violence and even risking death for their efforts to defend the rights of local communities, peasants, pastoralists and indigenous people to their land and environment. Many violations remain invisible and corruption and impunity are widespread. As competition for land intensifies against a backdrop of extreme global inequality, the situation is likely to get worse.

This session pays tribute to friends and colleagues who lost their lives fighting for land rights and explores how to fight back against the erosion of civic space and the growing number threats by building our movement to support and protect defenders of land and environmental rights.

HOW TO AVOID AND REVERT LAND GRABS: A PRACTICAL TRAINING

Since 2008-2009, commercial pressures on land have increased significantly, leading to a proliferation of large scale land deals. Non-transparent, irregular acquisition processes and poor social, economic and environmental performances of land use have characterised a large number of these deals, often referred to as land grabs. By combining short training courses with interactive discussions, this panel trains participants to avoid and/or revert deals that might negatively affect local populations and environment.

PLENARY: Fighting inequality to build a just world

Rising extreme inequality is a major threat to achieving sustainable development. The pressure on land and other natural resources is increasing and land ownership is becoming more concentrated, leading to a dramatic increase of inequality in rural areas. This session sheds light on the linkages between people-centred land governance and the root causes of inequality in rural areas but also on what can be done to reverse the current trend and who can do what, including by strengthening social justice organisations, empowering youth to participate in decision-making, promoting land and agrarian reform and tackling climate change.
